The town received a check in the amount of \$9,957.63 on the insurance claim for the lighting strike. The dump truck will cost the water department an additional \$11,500.00 bringing the total to \$41,500.00. Kelly Greulich was asked by the water board to see how the State Board of Accounts wants the town to handle the funds, since the truck was budgeted in 2018 but won't be ready or paid for until March 2019.

Chris Glenn stated the water department has 11 radio meters in stock, would like to order 2 more cases (54 radio meters) at a cost of \$ 125.00 each. Yesterday, EJP condensed the information from two guns and the manual black book into the new meter gun.

Scot Elliott asked Greulich to take off the agenda the invoice in the amount of \$ 10,579.32 for the water line that was hit during the construction of the Yellig Trail. Elliott stated the water board will pass on the surplus police car.

2019 BUDGET

As the budget stands we have about \$17,000.00 in expenses than the expected revenue in 2019 (with no capital projects in at this time). The board will finalize the budget at the November water board meeting.
