Jennifer Rich made a motion to adjourn the meeting at 7:42pm. Eileen Farmer seconded the motion.

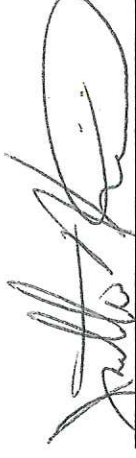
