

TOWN OF SANTA CLAUS PARK & REC BOARD
Monthly Meeting Minutes
August 3, 2026, 7:00 pm.

The Santa Claus Park Board met for their monthly meeting on August 3, 2026, at the Santa Claus Town Hall at 90 N Holiday Blvd, Santa Claus, IN. The meeting was called to order by Jonathan Goldsberry at 7:04 pm.

Park Board Members present: Jonathan Goldsberry, Jonathon Kincaid, and Eileen Farmer.

Also, present, Park and Recreation Director Zach Tischendorf.

Eileen Farmer made a motion to approve the minutes of the July 8, 2026, meeting. Jonathon Kincaid seconded the motion.

The LWCF grant application was submitted on Friday. Zach received confirmation that it was received.

The Town Council is going to appropriate money to get the soccer fields and Jay Cutler fields new lights for a November RFP.

Zach is working with PlayPros and CHA to discuss playground features.

Painting is being completed at Yellig Park.

Doorknob conversions to handles at SCCC to ensure ADA compliance is still being looked into.

The robotic mower should be approved at the coming Town Council meeting.

North Spencer Softball reached out to Zach to see if the Park Board would take over some of the softball operations such as ordering supplies, coaches' meetings, and scheduling umpires. The board shared some concerns about these duties taking Zach away from his other parks director's duties. The board recommended that Zach continue to do what he is doing now and the leagues maintain these duties.

We discussed the player fees for Yellig Park for the sports leagues. With the changes in the taxes, we will see a decrease in the tax revenue that the park sees. Zach proposed that we aim for a \$30 player fee, but by increasing it over three years at \$5 each year. These new fees would take effect at the beginning of 2027.

Eileen Farmer makes a motion to recommend an increase of \$5 per year for 2027, 2028, and 2029 for player fees at Yellig Park. Jonathon Kincaid seconded the motion.

Eileen Farmer made a motion to approve the Parks and Recreation vouchers in the amount of \$9639.65. Jonathon Kincaid seconded the motion.

Eileen Farmer made a motion to approve the SCCC vouchers in the amount of \$2228.61. Jonathon Kincaid seconded the motion.

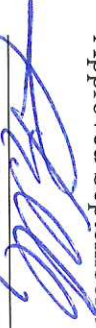
