Monthly Meeting Minutes
March 2, 2026, 6:45 p.m.

The Santa Claus Park Board met for their monthly meeting on March 2, 2026, at the Santa Claus Town Hall at 90 N Holiday Blvd, Santa Claus, IN. The meeting was called to order by Jonathan Goldsberry at 6:47pm.

Eileen Farmer made a motion to approve the minutes from the February 2, 2025, meeting. Jonathon Kincaid seconded the motion.

Spring Flings and Easter Things will be Saturday, April 4th from 10am-12pm CST.

The AEDs have been replaced. We have 2 Zoll AED3 at SCCC and Yellig Park. They have universal pads. One located in the lobby of SCCC and one by the water fountain in the foyer. At the park, one is located in each concession stand. These would only be accessible when sports are going on, coaches have codes to access them. Zach will research getting more of these at the park, possibly with one accessible at all times.

Zach got some of the plastic grip strips laid on the bridges at the park. He submitted a grant for additional strips to the trail bridges. He hopes to have a volunteer day to lay the remaining strips at the park this Spring.

The bottle filler has been received; it will be hung on the north side of the shelter house near the road.

Zach sent out a request for quotes for a SCAG Turf Tiger II to four dealerships.

- All Seasons Lawn Equipment: \$15989.00.
- Fischer's Furniture and Appliance: \$16399.00
- Booneville Lawn and Garden: \$15989.00, this includes a free set of blades, oil filter, oil for first oil change, and another oil filter
- Hagan's Outdoor Equipment: \$16399.00

Zach will confirm the maintenance and warranty.

Jonathan Kincaid made a motion to accept the quote from All Seasons Lawn Equipment out of loyalty to the company pending the inclusion of blades, and first oil change in the amount of \$15989.00 to be paid from 50% Parks operation and 50% from donation fund. If the inclusion of the package is not agreed upon, the bid from Booneville Lawn and Garden will be accepted in the same amount. Jennifer Rich seconded the motion.

The SCCC foyer restroom is scheduled to be completed in the week of March 23rd.

Eileen Farmer made a motion for the Spencer County Community Foundation to purchase and mount a drop box outside of the doors at the SCCC. Jonathon Kincaid seconded the motion.
