The Santa Claus Park Board met for their monthly meeting on May 4, 2026, at the Santa Claus Town Hall at 90 N Holiday Blvd, Santa Claus, IN. The meeting was called to order by Jonathan Goldsberry at 7:00 pm.

Thirty Little Bluestems have been planted in the landscaping at the SCCC to replace plants that had died out. The Circle S landscape bed was replaced with Dwarf Hamlin grass. Seventy-two Switchgrass plugs have been ordered for the Kasper Gate landscape bed, we should receive those in early June.

Jon Goldsberry suggested that we make a monthly social media post to help promote the SCCC gym memberships.

Zach received three quotes for grip strips of the bridges on the trails.

- Handi-Ramp is for 1000 aluminum deck strips at 4 feet long and 1 7/8 inches width in the amount of \$12109.50.
- CGS GripStrip Products Ltd. Is for 1000 plastic grip strips in the amount of \$5909.00
- Clear way Supply is for 1000 aluminum deck strips 30inches by 3 3/8inches in the amount of \$12600.00.

Jennifer Rich made a motion to recommend CGS GripStrip Product Ltd. Quote in the amount of \$5909.00. Using \$5000 from the Spencer County Parks Board Grant and \$909.00 paid from the Trails Equipment Fund (2530002451.00). Jonathon Kincaid seconded the motion.
