Eileen Farmer made a motion to approve the Parks and Recreation vouchers in the amount of \$10661.77. Jessi Mullen seconded the motion.



Next Park Board meeting will be held, September 6, 2023, at 7:00pm at the Santa Claus Community Center.


Jessi Mullen made a motion to adjourn the meeting at 9:03pm. Eileen Farmer seconded the motion.


