Seth Windell made a motion for the 1st reading of ORDINANCE 2021-12 THE TOWN OF SANTA CLAUS PROPOSED 2022 BUDGET in the amount of \$ 2,411,968.00 for all funds excluding water and wastewater and Patricia Vaal seconded the motion.

The public hearing for the 2022 budget will be at the October 11, 2021 meeting at 5:30 pm.

Michael Johannes stated we have several people in attendance tonight and if you would like to speak the council asked that you limit your comments two minutes or less, please.

COMMENTS FROM THE FLOOR

Patricia Vaal asked if she could speak first, stating she has concerns from her constituents. The quote from last month meeting, this is how it has been done in the past! Vaal stated well this is the present and everything we as the council do now impacts the future. For thirty years Vaal has spent her career cultivating, caring for, planning for the future of our children. This refinery known as Riverview turns my stomach. As a governing body representing the people of Santa Claus it is our job to assume responsibility for the endurance of our community as well as our neighbors. In March of this year the Chicago Tribune published an article stating Indiana leads the United States in pollutants. This was reported by the EPA. If the town does the preliminary work who will pay for that and Mr. Patmore the town pays you a retainer fee monthly but you also invoice for items above the retainer correct? Patmore stated yes to Vaal's question. Vaal prepared a resolution for the council as follows:

A RESOLUTION REGARDING THE COAL-TO-DIESEL REFINERY PROPSED FOR DALE,

WHEREAS, RIVERVIEW ENERGY HAS PROPOSED A COAL-TO-DIESEL REFINERY FOR THE TOWN OF DALE;

WHEREAS, THIS REFINERY WILL CAUSE AIR AND WATER POLLUTION, INCLUDING AIR POLLUTION PRESENTING A CANCER RISK EXCEEDING THE STATE GUIDELINES;

WHEREAS, THE REFINERY HAS PROPOSED TO DRAW GROUND WATER FROM AN AQUIFER THAT IS THE SOURCE OF DRINKING WATER FOR THE TOWN OF SANTA CLAUS;

WHEREAS, THE REFINERY HAS NOT YET ANNOUNCED WHERE IT WILL DISCHARGE ITS CONTAMINATED WASTEWATER;

WHEREAS, THE REFINERY WILL PAY NO PROPERTY TAXES IN TOWN OF SANTA CLAUS;

WHEREAS, THE REFINERY HAS PROVIDED NO GUARANTEE THAT IT WILL PAY FOR ANY NEEDED INFRASTRUCTURE IN SANTA CLAU;

WHEREAS, THE REINERY HAS PROVIDED NO GUARANTEE THAT IT WILL EMPLOY ANY WORKERS LIVING IN SANTA CLAUS;

WHEREAS, THE REFINERY MAY HAVE A NEGATIVE IMPACT ON TOURISM, AN ESSENTIAL INDUSTRY IN SANTA CLAUS;

BE IT THEREFORE RESOLVED, THAT THE TOWN OF SANTA CLAUS OPPOSES THE USE OF ITS DRINKING WATER BY THE REFINERY;

BE IT FURTHER RESOLVED, THAT THE TOWN OF SANTA CLAUS WILL NOT ACCEPT WASTEWATER FROM THE REFINERY;

BE IT FURTHER RESOLVED, THAT THE TOWN OF SANTA CLAUS WILL NOT PROVIDE FINANCIAL OR MATERIAL SUPPORT FOR THE REFINERY OR ANY ASSOCIATED EQUIPMENT OR PROJECTS, INCLUDING PIPELINES;

BE IT FURTHER RESOLVED, THAT THE TOWN OF SANTA CLAUS EXPRESSES ITS CONCERN ABOUT THE FINANCIAL AND HEALTH IMPACTS OF THE REFINERY.

Patricia Vaal made a motion for the Santa Claus Council support its people in their health and well-being in the future against Riverview toxins as an imminent threat and Kevin Burke seconded the motion.

Ayes: Vaal & Burke Nays: Little, Windell & Johannes Motion does not carry

COMMENTS FROM THE PRESIDENT

Michael Johannes stated the town has been talking with INDOT concerning the old HWY 245 and the intersection at CR 1450 N, the state would like for the town to take the road over. The state's offer is \$200,000.00 and giving the road over to the town to maintain. Russ Luthy was asked to get a preliminary quote from Ragle and that came in \$100,000.00 over what the state is offering. Luthy will be getting a few more quotes for the next meeting.

Michael Johannes gave an update on Riverview a discussion meeting took place at the Spencer County LEDC room on September 8, 2021 those in attendance from Santa Claus were Kelly Greulich, Kevin Patmore, Scot Elliott, Russ Luthy and Johannes. Basically, the town of Santa Claus informed Riverview that Riverview would be responsible for all cost associated with the water project. All parties were represented at the meeting, it was suggested by Riverview that a Memorandum of Understanding (MOU) be drafted. Patmore has drafted the document and it was sent to the council prior to this meeting for review, if the council approves the document tonight then it will be sent to Dale council and Riverview representatives for review.

Kevin Burke asked who were the representatives from Dale and Riverview? Johannes stated Ray Striegel, Deloss Painter & Bruce Cissna from Dale. Vaal asked so two council members from Dale but our council members were not asked, Johannes said it was discussed at a meeting who would attend and this is how it has been done in the past with town business. Johannes stated the representatives from Riverview were Greg Mural & Roland Ott.

Scot Elliott stated since it was identified who was at the meeting, we won't go over that again. Going into the meeting the town stated we can supply water but treating their water is not something the town is interested in. A discussion followed about financing and a formal document. The MOU states no less than 2 million gallons per day and future need for 4 million gallons per day. The raw water line has absolutely nothing to do with the town's drinking water system. The town will rely on preliminary engineering concerning the size of line, a rate study would have to be done for Riverview as well among many other items. Riverview would have to fund the entire project and the money would have to be upfront.

Patmore stated in the MOU paragraph # 2 it states that preliminary engineering of the water project immediately upon Riverview depositing with the Town of Santa Claus good funds in the sum of ______. We don't have that number yet but Midwestern is working on the cost estimate.

Vaal stated to clarify one more time Riverview has to pay for engineering cost if the Town of Santa Claus decides to study the Riverview project.

The only obligation in this agreement is under 9 (b)- This agreement is not intended to and does not give any person who is not a Party to it any rights to enforce any of its provisions. Nothing in this Agreement will be construed as creating a binding legal relationship between the Parties, except with regard to Santa Claus's use of funds provided by Riverview for the development of the Water Project pursuant to Paragraph 2 of this Agreement. This Agreement is a broad statement of intent which sets forth the general basis upon which Parties wish to proceed with regard to the Water Project. No legal liability will arise in respect of any subject matter hereof unless a subsequent binding agreement is negotiated, approved, executed and delivered by the Parties to this Agreement.

Michael Johannes and Jason Little will be meeting at town hall tomorrow 9/14/2021 at 3:00 pm with citizens that are against the Coal to Diesel Plant.

Ron Etienne asked how will Riverview dispose of the wastewater? Elliott stated Roland Ott of Riverview informed those present at the meeting Riverview is looking into treating the wastewater onsite and then back into the Ohio River. This has nothing to do with Santa Claus.

Jennifer Mayhall asked the council to do the right thing, there are so many people dying of cancer, having health issues in the area why would you want to contribute to those issues?

Jason Little made a motion to send the Memorandum of Understanding (MOU) to the town of Dale and Riverview to look over and Seth Windell seconded the motion.

Greulich received a quote from Jaws Collision Center in regards to the Christmas trees on our welcome signs coming into town. To fully restore and refinish the four Christmas trees the cost will be \$6,600.00. If the council approves a motion will be needed.

Seth Windell made a motion to approve the restoring and refinishing of the four Christmas trees by Jaws in an amount not to exceed \$ 6,600.00 and Patricia Vaal seconded the motion.

That would require information on the employees W-2 as a benefit. Patmore stated he can look into the matter but they need to reconsider what they are asking for.

The council at this time agreed that employees that are off because of COVID must use PTO time if they want to be paid for loss time. The council may revisit this issue from time to time especially if a employee can show proof of vaccination.

ORDINANCE 2021-11

AN ORDINANCE TO ESTABLISH THE ARP CORONAVIRUS LOCAL FISCAL RECOVERY GRANT FUND (FUND #176)

BE IT ORDAINED BY THE SANTA CLAUS TOWN COUNCIL OF THE TOWN OF SANTA CLAUS, INDIANA:

- 1, The Town Council of the Town of Santa Claus, Spencer County, Indiana, recognizes that a need now exists for the establishment of the ARP Coronavirus Local Fiscal Recovery Grant Fund (Fund #176) pursuant to Indiana Code 5-11.
- 2. The sources of funding for the newly established fund will include monies allocated to the Town from the American Rescue Plan Act of 2021 (ARPA). The monies within this fund shall be used for eligible purposes of the ARPA.
- 3. Expenditures from the ARP Fund must be made in accordance with the Plan adopted by the Town Council that corresponds to the provisions of Title VI of the Social Security Act (42 U.S.C. 801 *et seq.*), as amended Section 9901(a) of the ARP and the Indiana State Board of Accounts State Examiner Directive 2021-
- 1. Expenditures from the ARP Fund may be used only for the purposes prescribed in Title VI of the Social Security Act (42 U.S.C. 801 *et seq.*), as amended Section 9901(a) of the ARP. Those eligible uses are:

To cover costs incurred by the Town of Santa Claus, Indiana by December 31, 2024:

- A. To respond to the public health emergency with respect to the Coronavirus Disease 2019 (COVID-19) or its negative economic impacts, including: assistance to households, small businesses, and nonprofits, or aid to impacted industries such as tourism, travel, and hospitality;
- B. To respond to workers performing essential work during the COVID-19 public health emergency by providing premium pay to eligible workers of the Town that are performing such essential work, or by providing grants to eligible employers that have eligible workers who perform essential work;
- C. For the provision of government services to the extent of the reduction in revenue to the Town due to the COVID-19 public health emergency relative to revenues collected in the most recent full fiscal year prior to the emergency; or
- D. To make necessary investments in water, sewer, or broadband infrastructure.

The Clerk-Treasurer will review the requested use of monies for compliance with ARPA requirements. The Clerk-Treasurer will also maintain detailed accounting record of the fund to provide for future audits of the ARP fund. The Town's existing internal control policies, as amended from time to time, shall apply to administration of the ARP Grant Fund.

The Town Council has developed a plan that details the specific uses of the Fund ("the "Plan"). The Plan is to utilize all available ARP funds as follows:

- i. If the Town receives a State Water Infrastructure ("SWIF") Grant from the Indiana Finance Authority, all ARP funds received in 2021 and 2022 shall be used to accomplish the water utility infrastructure projects contained in the Town's SWIF Application submitted July 15, 2021;
- ii. If the Town does not receive a SWIF Grant, the Town will use the ARP Fund to make necessary investments in water and/or sewer infrastructure.

This Ordinance and the Plan may be amended as any other Ordinance or Plan as long as the amendment complies with the requirements of the ARP and any other formally issued guidance of the SBOA. Any specific appropriations approved by the Town Council shall be deemed a part of the Plan or an amendment to the Plan, as appropriate, when such appropriations are made.

- 4. Non-Reverting Fund Any and all monies in the ARP Grant Fund at the end of the calendar year shall not revert to another fund but shall remain in said fund as a separate non-reverting fund.
 - 5. This Ordinance be in full force and effect from and after its passage by the Town Council.
